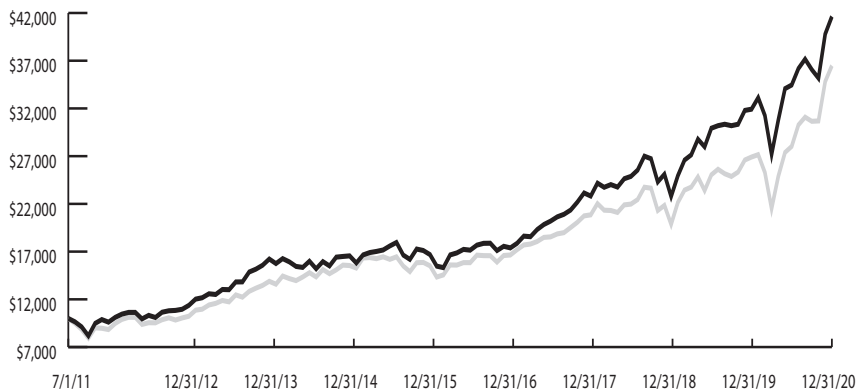

INVESTMENT STRATEGIES

The D.F. Dent Midcap Growth Fund (the "Fund") invests primarily in U.S. exchange-listed equity securities, including common, preferred and convertible stock, real estate investment trusts ("REITs"), American Depositary Receipts and exchange-traded funds that the Adviser believes possess superior long-term growth characteristics and have strong, sustainable earnings prospects and reasonably valued stock prices. The Fund may also invest in companies that do not have particularly strong earnings histories but do have other attributes that the Adviser believes may contribute to accelerated growth in the foreseeable future. Under normal market conditions, the Fund invests at least 80% of its net assets (plus borrowings for investment purposes) in equity securities of medium-size companies ("80% Policy"). For these purposes, the Fund's Adviser defines medium-sized companies as those companies with market capitalizations in the range of \$1.298 billion to \$53.5 billion, which was the three-year average of the market capitalization range of companies in the Russell Midcap Growth® Index on May 31, 2018, 2019 and 2020.

FUND MANAGEMENT

D.F. Dent and Company, Inc. is a registered investment adviser and has provided investment advisory and management services to clients since 1976. As of December 31, 2020, D.F. Dent and Company, Inc. had approximately \$9.6 billion in total firm assets. The firm is 100% independently owned and is unaffiliated with any other investment organization. The Fund's portfolio is team-managed by four portfolio managers, Thomas F. O'Neil, Jr., CFA, Matthew F. Dent, CFA, Bruce L. Kennedy II, CFA, and Gary D. Mitchell, J.D., who are jointly responsible for the day-to-day management of the Fund. They have each served as portfolio manager of the Fund since its inception in 2011.
