

## INVESTMENT STRATEGIES

The D.F. Dent Small Cap Growth Fund (the "Fund") invests primarily in U.S. exchange-listed equity securities, including common, preferred and convertible stock, real estate investment trusts ("REITs"), American Depositary Receipts and exchange-traded funds that the Adviser believes possess superior long-term growth characteristics and have strong, sustainable earnings prospects and reasonably valued stock prices. The Fund may also invest in companies that do not have particularly strong earnings histories but do have other attributes that the Adviser believes may contribute to accelerated growth in the foreseeable future, including initial public offerings. Under normal market conditions, the Fund invests at least 80% of its net assets (plus borrowings for investment purposes) in equity securities with small market capitalizations ("80% Policy"). For these purposes, the Fund's Adviser considers small market capitalizations companies as those companies with market capitalizations in the range of \$11.7 million to \$11.7 billion, which was the three-year average of the market capitalization range of companies in the Russell 2000 Growth® Index on May 31, 2018, 2019, and 2020.

## FUND MANAGEMENT

D.F. Dent and Company, Inc. is a registered investment adviser and has provided investment advisory and management services to clients since 1976. As of March 31, 2021, D.F. Dent and Company, Inc. had approximately \$9.7 billion in total firm assets. The firm is 100% independently owned and is unaffiliated with any other investment organization. The Fund's portfolio is team-managed by two portfolio managers, Matthew F. Dent, CFA, and Gary D. Wu, Ph.D., CFA, who are jointly responsible for the day-to-day management of the Fund.
