### Investment Approach

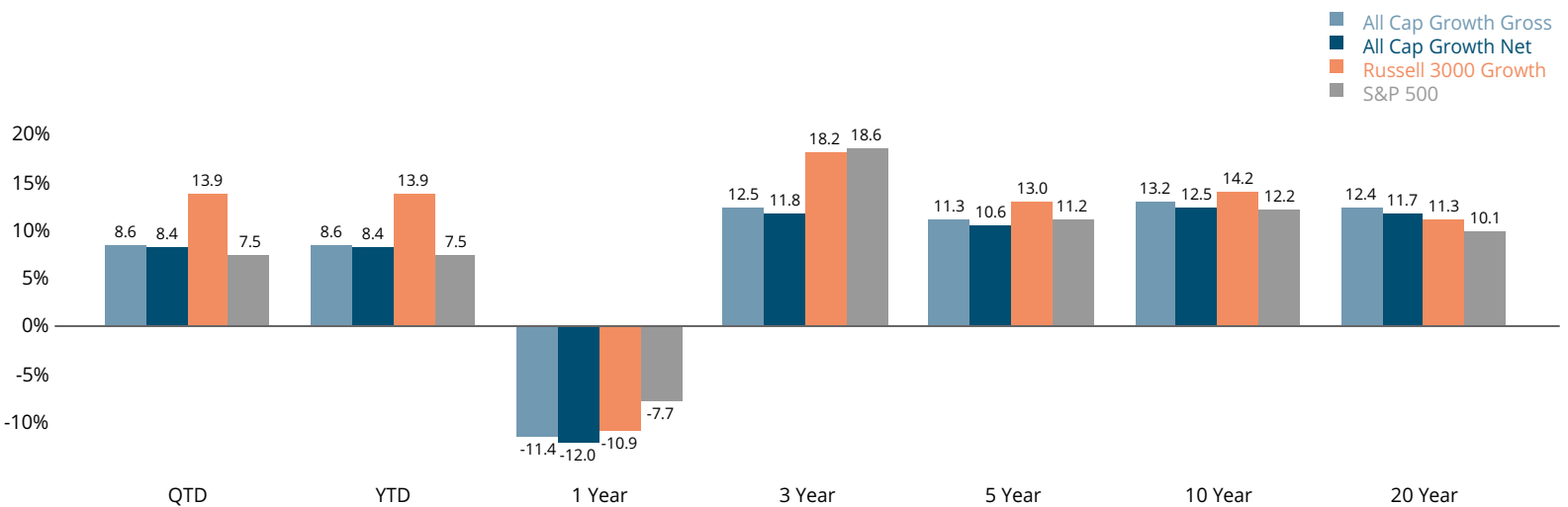

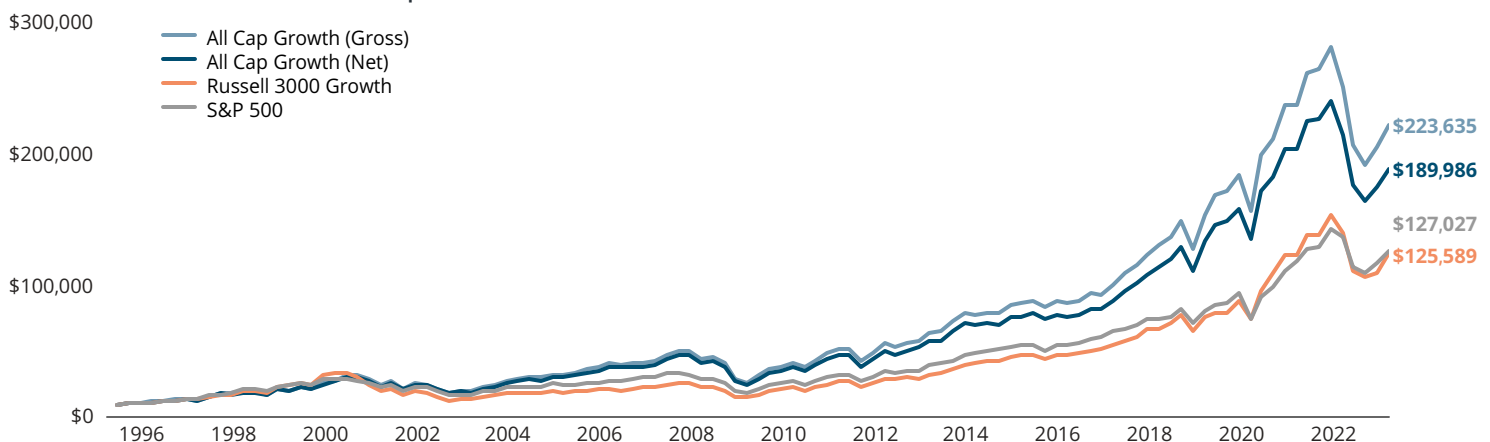
