

Investment Strategies

The D.F. Dent Small Cap Growth Fund (the "Fund") invests primarily in U.S. exchange-listed equity securities, including common, preferred and convertible stock, real estate investment trusts ("REITs"), American Depository Receipts and exchange-traded funds that the Adviser believes possess superior long-term growth characteristics and have strong, sustainable earnings prospects and reasonably valued stock prices. The Fund may also invest in companies that do not have particularly strong earnings histories but do have other attributes that the Adviser believes may contribute to accelerated growth in the foreseeable future, including initial public offerings. Under normal market conditions, the Fund invests at least 80% of its net assets (plus borrowings for investment purposes) in equity securities with small market capitalizations ("80% Policy"). For these purposes, the Fund's Adviser considers small market capitalizations companies as those companies that, at the time of purchase, have market capitalizations within the range of companies included in the Russell 2000 Growth Index on a rolling three-year basis. As of September 30, 2024, the minimum and maximum market capitalizations on a rolling three-year basis within the Russell 2000 Growth Index were \$2 million and \$59 billion, respectively. Following a Fund's investment in a security, it may appreciate or depreciate significantly from the time of the Fund's investment.

FUND MANAGEMENT

D.F. Dent and Company, Inc. is a registered investment adviser and has provided investment advisory and management services to clients since 1976. As of September 30, 2025, D.F. Dent and Company, Inc. had approximately \$9.8 billion in total firm assets. The firm is 100% independently owned and is unaffiliated with any other investment organization. The Fund's portfolio is team-managed by three portfolio managers, Matthew F. Dent, CFA, Gary Wu, Ph.D., CFA, and Brady M. Cox, CFA, who are jointly and primarily responsible for the day-to-day management of the Fund. Matthew F. Dent and Gary Wu have each served as portfolio manager of the Fund since its inception in November 2013. Brady M. Cox has served as a portfolio manager of the Fund since January 2025.
